## **ANNOUNCEMENT FROM THE GENERAL LEGAL COUNCIL**

### **SUSPENSION OF LAWYER SEIDU H. NASIGRI FROM LEGAL PRACTICE**

**NOTICE IS HEREBY GIVEN** that **LAWYER SEIDU H. NASIGRI** has been suspended from legal practice for a period of six (6) months commencing from **1<sup>st</sup> November, 2019 to 30<sup>th</sup> April, 2020.**

The above-named lawyer was charged with one count under Rule 7 (1) of the Legal Profession (Professional Conduct and Etiquette) Rules, 1969 (L.I. 613) as follows:

#### **Count 1**

That he, having withdrawn his services as a professional lawyer representing Kijani Resources Ghana Ltd (1<sup>st</sup> Defendant) in the civil case with Suit No. E2/04/2015, failed to apply to the Court for an order to be made in that regard pursuant to Order 75 r 6(1) of the High Court (Civil Procedure) Rules, 2004 (C.I. 47) and therefore as the lawyer on record, he failed to provide his client with the relevant Court processes served on him, thereby not protecting the interest of his client.

He was further charged with a second count under Rule 7 (1) of the Legal Profession (Professional Conduct and Etiquette) Rules, 1969 (L.I. 613):

### Count 2

That he, as the professional lawyer on record appearing for Kijani Resources Ghana Ltd (1st Defendant) in the civil case with Suit No. E2/04/2015, failed to uphold the interest of his client by not filing his written legal submissions on his client's behalf pursuant to the directions of the High Court, Tema on 27<sup>th</sup> October 2014.

Lawyer Seidu Nasigri was also charged with a third count under Rule 9 (6) of the Legal Profession (Professional Conduct and Etiquette) Rules, 1969 (L.I. 613):

### Count 3

That he, as the professional lawyer on record appearing for Kijani Resources Ghana Ltd (1st Defendant) in the civil case with Suit No. E2/04/2015, failed to attend Court or make any arrangements for some other lawyer to be present in Court during the prosecution of the said suit, thereby acting in breach of his duty to the Court, his client and his profession.


He pleaded guilty to all three counts and was accordingly convicted on his own plea.

During the period of the suspension, he shall not hold himself out as a Legal Practitioner or attend Chambers, or render, or purport to render any professional legal services to the public. He shall not attend chambers at anytime during the period of his suspension.

The licence of **LAWYER SEIDU H. NASIGRI** to practice for the next six (6) months is hereby withdrawn forthwith.
